Course Description: Prequalification of contractors is a method used to manage the risks of an open tender process. It ensures the contractors invited to bid on the project have demonstrated applicable experience and are capable of delivering the necessary quality and value. This course is a primer on contractor prequalification and describes who benefits from the process, the applicable project delivery methods, the role of the architect, the typical information requested of the contractor, and when to use prequalification and when not to.
